LEGAL AUDIT SUMMARY & DEEMED DELIVERY RULE:

1. **Exclusivity of Group:** Established as the sole official forum for PEB communications under binding written directive.
2. **Forensic Preservation of Deleted Items:** 18 total deleted/revoked messages from SBW across group and 1-on-1 chats are permanently preserved with exact database timestamps, stanza IDs, and reconstructed transcripts.
3. **Uncontested Contract Terms:** Master Contract (37L) and Deliverables Matrix published without formal written objection within 48 hours, establishing full legal deemed acceptance under project governance rules.
